



## 2025 Season Player Fee Agreement

- Option 1 (Sponsor/Donation):** \$500 worth of sponsorships/donations.

- Option 2 (Player Fee and Sponsorship):** \$350 in Player Fee and \$100 or more in Sponsorship Donation. All due by (3/01/25)

\$225 due by (3/01/25)

Players agree to obtain sponsors/donations in the amount of \$500 *or* pay the player fees in the amount of \$450 **in full by March 1, 2025**. If not paid in full by deadline, player may not participate in games until paid in full. Upon receipt of the full player fee, each player will be given a Lawmen Pride Pack. All player fees are used for travel hotel, league dues, and other team expenses.

### Early Payment Incentive Program:

To encourage players to get fees paid in a timely manner we are excited to offer the Early Payment Incentive Program. Any player who has their team fees paid in full by (January 25, 2025) will receive a \$25 discount. Bringing your team fees to \$425.

### Attendance Incentive Program:

To encourage a high level of practice attendance we are excited to offer the Attendance Incentive Program. Any player that completes the following requirements will receive a \$100 reduction in dues for **THE FOLLOWING SEASON:**

1. Pay the player fee in full by March 1, 2025.
2. Attend every game. (If you are sick/hurt but present, you still qualify)
3. Miss no more than two practices.

### Sponsorship Incentive Program:

In an attempt assist player with the expenses of playing, we have created a sponsorship incentive program. Simply get a person or business to donate to the team in your name. We have a sponsorship package packet for interested parties. All sponsorships/donations are tax deductible:

- a) \$500 covers player fee and includes Lawmen Pride Pack
- b) \$1,000 worth of sponsorships; eligible for \$100 reimbursement for flight & a)
- c) \$1,500 worth of sponsorships; eligible for \$250 reimbursement for flight & a)
- d) \$2,000 worth of sponsorships; eligible for \$500 reimbursement for flight & a)
